6.1 Lee/Lansing Project #R1016-001299, Request for a CUP by Aldi's Market 2246 N Lake Ave in order to sell beer and wine. Aldi's will be open 7 days a week from 9 to 9. Beer and wine will occupy 4% of total shelf space and will be located in the rear of the store. In order to obtain community opinions, Council Members knocked on 250 doors, 80 responses gave results of 47 yes votes, 8 no votes, and 25 no opinion votes.

Conditions to be recommended are 1) CUP applies to Aldi's only, not to any future sub tenants, 2) Beer and wine will be sold only on the designated shelves, 3) The beer and wine will not be refrigerated, and 4) There will be no advertising of beer and wine on the exterior of the building or on walls and fences.
