# ii. 735 E. Altadena Drive, Permit R2010-00160-(5) CUP 201-000022

- The applicants, Alta Loma, LLC and Thrifty Payless, Inc. are requesting aconditional use permit (CUP) to authorize all commercial uses in a shopping centerin the CPD (Commercial Planned Development) zone and to authorize the continued sale of alcoholic beverages (ABC type 21: beer, wine, and distilled spirits) for off-site consumption from an existing Rite-Aid drugstore in the shopping center. All commercial use and the sale of alcoholic beverages in the CPD zone require a CUP pursuant to Section 22.28.340 of the Los Angeles County Code. The shopping center was zoned CPD from C-2 (Neighborhood business) on March 26, 1991. The Rite Aid currently does not have a CUP for alcohol sales because alcohol sales were established before CUP's were required. Alta Loma also proposes restriping the parking lot and installing additional landscaping.
