The website committee is optimizing the site and will propose plans to revamp the website within a month for review by the Executive Committee and approval by the entire body. A message on the website will reference the changes being made.
3. PUBLIC	SAFETY
3.1.	California Highway PatrolOfficer Phillip Cooper provides a report on behalf of Officer Mike Ulloa and invites the public to Altadena CHP Touch-a-Truck, Saturday, September 23, 2017, 9:00 AM-3:00 PM, Santa Anita Race Track, 285 W. Huntington Drive, Arcadia, CA. The new radar trailer that was located on Allen Avenue, south of New York Drive, has been relocated to Altadena Drive and Crest Drive. July and August reports show a decrease in traffic collisions, from 27 in July to 17 in August. No DUIs were reported in August. The community is asked to be aware of Southern California Edison's construction and drive consciously. Drivers are encouraged to use windshield wipers and headlights when it is raining. CHP is considering radar trailer placements in the following areas: Altadena Drive, between Glenrose Avenue and Olive Avenue, and Fairoaks Avenue and Woodbury Road. The radar trailer has a "stroke" feature to detect high speeds, but it does not have a camera for recording.

There was a decrease in overall crime, from 53 in July to 47 in August, and petty and grand larceny, from 25 in July to 19 in August. No residential burglaries were reported in Census Tracts 4603.01, 4603.02 and 4610. Jamahl Butler, Deputy District Ranger, Los Angeles Ranger District, serving the National Forest areas adjacent to Altadena, Pasadena, La Canada and Sunland-Tujunga, reports that the US Forestry is not set-up to address the homeless. The US Forestry has partnerships with Supervisor Kathryn Barger's Office, LAHSA, and Sheriff's Department to help resolve homeless encampment issues in the forest. The homeless are migrating into campgrounds in the National Forest at sites near JPL and foothill cities. The forestry orders with stay limits have been reenacted to encourage campers to move. Homeless encampments in Gould Mesa have decreased from 14 tents to 8. In reply to inquiries, council is instructed to contact the recreation officer at the district office for site availability and group campgrounds, and council is encouraged to keep "open fires" in public campgrounds as a priority for discussion.
