## REPORT J. Matthews, Councilwoman

The following information is shared responses addressing concerns deemed to be of great importance to residents of CT 4603.01. The responses are to be incorporated with all reporting for the CT.

#### **Public Works Projects:**

Projected Schedule of tree trimming for the entire CT is fall of 2014 – 2015. Scheduling is according to the growth. Tree trimming completed in Florecita Farm area (the north side of Altadena Dr. from Casitas Ave. to Florecita Dr., Florecita Dr. north to Crestford Dr., and south on Crestford Drive to Florecita Way).

Street maintenance is being addressed in specific areas of CT 4603.01. Pedestrian signage on Casitas Ave. anticipated to be completed within the next six weeks.

Constituent concerns of littering on paths (El Prieto and Rising Hill) leading up to and including general area of the Lincoln Avenue Water tank/reservoir. The concerns are being addressed to eliminate the possibility of fire and health hazards. A fire in this area could be devastating to the entire community. Anticipated response forthcoming.
