- 3.1 Altadena Sheriff's Station Captain Ethan Marquez
 - 3.1.1 CERT meeting: Nov 5, 4–6 pm, restarting community emergency response team.
 - 3.1.2 Altadena Forever Run: Jan 4; 10K/5K/1K; fundraiser for fire survivors and Sheriff Foundation.
 - 3.1.3 Crime: Burglaries steady; catalytic converter thefts increasing (Prius most targeted); recent arrests made.
 - 3.1.4 Rebuild security: Homeowners encouraged to email station for security checks during construction.
- 3.2 California Highway Patrol Officer Keller

- 4.3.2 Partners: CORE, ARC, Community Women Vital Voices, UCLA CityLab, LA County, LA for LA, Department of Angels. Coordination with POSTFIRE and philanthropic partners
- 4.3.3 Multiple units on-site, including a ~1,200 sq ft model and smaller ADU-scale units

 - 4.4.1 Public Works manages roads, flood control, building and safety, waterworks, catch basins, and sewers. 24/7 dispatch available for potholes, signals, trash, flooding, graffiti, and illegal dumping.
 - 4.4.2 Residents encouraged to use the LA County Public Works app (photo reporting and Service Locator).
 - 4.4.2.1 Promoted Ready LA County preparedness steps: plan, supplies, stay informed, get involved.
 - 4.4.3 Hazard page includes alerts and Mud Flow Protection Map; at-risk areas should have received door hangers. Postfire mudflow risk remains elevated for several years.
 - 4.4.4 Safety Resources Emergency Survival Guide available in 15 languages. Recommended Watch Duty app for real-time fire updates.

 - 4.4.5.1 Concrete for bridge abutments completed, remaining concrete/retaining wall work finishing this week.

 - 5.1.1 Public Health enforces noise rules; post-Eaton Fire variance allows Sunday construction 7 a.m.–7 p.m.
 - 5.1.2 Department is gathering community input on further adjusting construction hours.
 - 5.1.3 Anonymous survey (QR code) open to residents and builders to weigh earlier/later hours and limited holiday work.

- 6.1 Land Use Committee Diane Marcussen, Chair
 - 6.1.1 McDonalds Rebuild CUP RPPL2023004561- 1306 N. Altadena Dr.
 - 6.1.1.1 Project proposed with larger dining room/kitchen and a dual-lane drive-thru to reduce traffic queuing. Includes 4,142 sq ft building, ~40 seats, 17 parking stalls, bike/EV amenities, and improved signage and landscaping.
 - 6.1.1.2 Staffing 70–80 employees; same operating hours as before.
 - 6.1.1.3 Land Use Committee recommended approval of the CUP; ATC unanimously supported sending a letter of support.
 - 6.1.2 Bar Betsy CUP RPPL2024-003530 871 E. Mariposa St.
 - 6.1.2.1 Café-style restaurant requesting beer and wine sales for on-/off-site consumption; community outreach showed no opposition.

6.3 Holiday Party – Victoria Knapp, Chair

6.3.1 Chair Knapp announced that the December 19, 2025, ATC meeting will be held at the Rose Bowl in the UCLA Bruins locker room through a partnership with the Rose Bowl.

- 6.3.2 Attending Altadena residents will receive a stadium and museum tour and have an opportunity to go onto the field; light refreshments will be provided.
- 6.3.3 Chair Knapp noted this will be her final holiday meeting as Chair.

6.4 Education – Councilmember Moulden, Chair

- 6.4.1 Chair Isis Molden reported that PUSD open enrollment timelines are set (sibling priority begins Oct 21; lotteries in Jan–Feb 2026).
- 6.4.2 Coalition of Northwest PUSD Families drafted a resolution seeking a three-year moratorium on involuntary teacher reassignments at Eaton Fire-impacted schools (Jackson, Altadena Arts, Elliot, John Muir).
- 6.4.3 Resolution aims to prevent mid-year teacher moves that further disrupt and traumatize affected students; Chair Molden proposed an ATC support letter to the PUSD Board.
- 6.4.4 Council discussion noted concerns about timing, budget implications, and limited review time, as well as strong support for stability and continuity for students.
- 6.4.5 A motion to send the letter was tabled; Council Member Chipola's motion to conduct the vote by email before the Oct 23, 2025, PUSD meeting passed by majority (three opposed, no abstentions).
- 6.4.6 Main motion remains tabled pending the email vote; members were asked to respond promptly.

6.5 AEFRF – Milissa Marona

- 6.5.1 On Sept 30, 2025, the Advisory Committee distributed ~240 grants totaling \$225,000 to Altadena residents.
- 6.5.2 Individual grants ranged from \$500–\$1,000 depending on need and available funds.
- 6.5.3 Fundraising is ongoing, with plans for additional distributions in early 2026.
- 6.5.4 Community encouraged to donate at eatenfirefund.com.

7 GENERAL PUBLIC COMMENT

7.1 David Scabinsky –raised concerns about long wait times at the understaffed Permit Center and urged broader recovery support for all Altadenans, noting his own difficulty accessing assistance. He recommended adding siren-based emergency alerts and creating a unified civil defense corp. He also requested the release of CHP, Sheriff, and County Fire after-action reports, expressing frustration that they remain unavailable six months after the fire.

- 7.2 Karen Gibson from Neighbors Building a Better Altadena thanked the community for the strong and generous response to this year's ATC candidate process and invited residents to the virtual candidate forum on October 28 from 6:30–8:30 p.m. She requested volunteer tech support for the event and noted that altadena.org will not be available for this election cycle. She encouraged the Council and Education Committee to ensure electronic voting is possible given widespread displacement after the fire. She closed by thanking Chair Isis Molden for her inclusive and tireless work organizing the candidate slate.
- 7.3 Alan Shay A longtime resident and former Little Red Hen owner, Alan Shay expressed pride in Altadena's resilience and praised council members for their leadership during the recovery. He offered his media tech company's support to help ATC candidates share their stories and emphasized the importance of strong, consistent leadership as new members step forward. He recalled his childhood in Altadena as a model of true community and encouraged continued support for emerging leaders in this next chapter.
- 7.4 Bree Jensen spoke on behalf of more than 600 Altadena residents who signed a petition requesting that one horse be allowed on lots of 9,000 sq ft or larger. She described the strong community response, including memories and historical photos of horses in Altadena, and noted the town's long equestrian history. She shared that caring for a horse during COVID provided meaningful emotional support for her family and emphasized that horses can aid healing and resilience as the community recovers from the Eaton Fire. She requested that the Town Council place the issue on a future agenda for discussion.
- 7.5 Matthew Lorscheider representing the Northwest PUSD Parents Coalition, urged support for a resolution to prevent mid-year teacher reassignments at fire-impacted Altadena and Northwest Pasadena schools. He described recent disruptions at Jackson and Altadena Arts Magnet caused by a teacher being moved weeks into the school year, resulting in overcrowding and unstable dual-language classes. He emphasized that students already facing COVID and fire-related trauma need stability, and clarified the coalition is not opposing budget cuts or annual staffing moves—only mid-year changes at affected schools.
